Comm. Bostwick motioned to approve the agenda. Comm. Christianson seconded, and the motion carried.

Approval of Minutes – June 18, 2018

Comm. Bostwick motioned to approve the minutes. Comm. Reed seconded, and the motion carried.

Discussion and possible action on creation of Milton Area Veterans Memorial Subcommittee or Friends Group

Comm. Reed motioned to create a subcommittee consisting of five members including Comm. Bostwick as the Parks & Recreation Commission representative for the Milton Area Veterans Memorial to review names for the memorial and questions on wording on bricks. Comm. Snow seconded, and the motion carried.

Discussion and possible action on design and fundraising for Story Gardens

a. 2018 Milton Garden Walk

Director Cushman stated that approximately 190 people attended the Milton Garden Walk and about \$2,500 was raised with a portion going to the Milton Garden Guild for their work organizing the event.

The commission discussed the status of the planning process for Story Gardens.

Discussion and possible action on Ice Age Trail Summer Hike Event

The commission decided to work on hosting an event potentially on September 29, 2018 called Harvest Hike & Hayride. Attendees will walk the Ice Age Trail route through the city, and then the commission will offer hayrides back to the other side of the City where there will be food and activities. Comm. Bostwick discussed modifications needed to block traffic during the Milton Optimist Club run on the 4th of July.


Set Next Meeting Date
