Engineering Status Report
October 4, 2016

- **2016 Water Main Improvements** – The contractor has completed major construction work. Only punch list items remain.
- **South High Pressure Zone Water Main** – The contractor has completed major construction work. Only punch list items remain.
- **Well 2** – Work is ongoing. The contractor has to complete the lawn restoration and SCADA work. Upon completion of the SCADA work the well startup process will begin.
- **Booster Station/PRV** – A preconstruction meeting has been held. The Contractor has started to provide shop drawings for review. Construction is scheduled to begin in early October.
- **Municipal Drive Ditch Grading** – The project is near completion. The Contractor has only restoration and cleanup work to complete.
- **2016 Pavement Improvements** – The construction of this project has started. The Merchant Row Parking Lot should be paved by the end of this week. Chicago Street near the ethanol plant should be completed by the end of next week. Project completion is anticipated in mid to late October.
- **Phosphorous Preliminary Compliance Alternatives Plan** – The final report was submitted to the DNR last week.
- **Vincent Street Water Main** – The plans and specifications are nearly complete. We are waiting for authorization to seek bids.

Subject: Discussion and Possible Action Regarding Brush Collection Time Limits.

Summary

Our current policy for brush collection allows property owners to place brush at the curb without any limits on quantity. Recently, we had an incident where we collected brush at one site for 3.5 hours.

The concern is that with an anticipated increase next year in enforcement of the hazardous/dead tree ordinance due to the Emerald Ash Borer we will have this occur on a regular basis.

We would like to have a change in the policy that would have a one hour limit on brush collection for each scheduled collection time. After an hour, the owner would be charged for the cost of collection. We would not do work and then charge an owner. They would be notified before work began of the possibility of a cost. We rarely, at the present time, have a property that has over an hour of collection occur.

Recommendation

If the committee agrees with this policy change a resolution and/or ordinance change will be prepared for consideration.
